Preparation Suggestion

1. Defrost overnight in the refrigerator or 2 to 2 ½ minutes in the microwave on high (wrapped in a paper towel to keep moisture in).
 2. Preheat oven or air fryer to 400°F.
 3. Bake for 7-10 minutes or until bites is golden brown.
- Pan fry** - from defrosted, heat skillet over medium heat, Add oil to coat pan and add beefless bites. Cook until deep golden colour stirring occasionally.

Place on center plate with other components as is or slice and present open side facing outwards

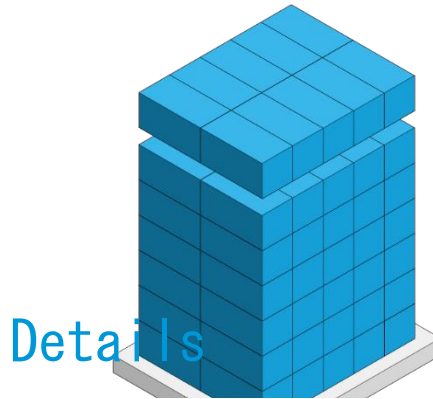
